

# Overnight Red-Eye Flight Contest

## DESCRIPTION OF THE CONTEST:

The Overnight Red-Eye Flight Contest is designed to give participants the chance to submit a story about their wildest flight experience onboard an airplane in 100 words or less. The best stories will be chosen by film industry judges and the winner will receive a round trip ticket to New York City. The contest winner will fly from their home town to Los Angeles and board a red-eye flight from LA to NYC, including hotel accommodation in NYC, with a return flight back home the following day. The "Overnight Red-Eye Flight" will be awarded to the participant who submits the best entry as determined by the Contest sponsor, Fusion Film Group (the "Producer"), in their sole discretion in accordance with these Official Contest Rules.

**ELIGIBILITY:** This Contest is open to anyone who is 18 years of age or older (must be able to present proof of age on demand. Failure to present proof of age may result in disqualification) Participant.

## OFFICIAL CONTEST RULES:

(a) Submissions must be submitted during the Contest Period beginning April 1, 2012 at 12:00 am (PST) ending August 1, 2012 at 11:59 pm (PST). Producer's clock is the official clock and sole determinant for the purposes of a valid submission in this Contest. The Submission is time-stamped when the Participant clicks on the Submit button at the completion of the submission process. Producer or its designated representatives reserve the right to disqualify any Submission that does not conform to these Official Contest Rules or as determined by Producer at its sole discretion.

(b) You must retain a copy of your written Submission in its original form after uploading it to the Site. If you are selected as a winner, you will need to provide Producer with your written Submission in its original form. Failure to do so may result in disqualification and the selection of an alternate winner. By entering the Contest, Participant agrees, acknowledges and understands that all Submissions, in whole or in part, may be posted on the Site for viewing by the general public and the advertising and marketing of the Film, and grants the Producer and its successors, assignees, licensees and designees at its sole discretion in perpetuity exclusive license to publish, display, exhibit, distribute, reproduce or otherwise use the Submission for any purpose whatsoever without further notice or compensation, in any and all forms of media now known or hereafter devised worldwide in perpetuity. Sponsor does not guarantee the posting of any Submission and reserves the right not to post a Submission for any or no reason. All Submissions become the property of Producer and will not be returned to the Participant.

(c) The Submission must be your own original work, created solely by you; must not have been previously published, released or distributed in any form; must not have won any award; and must not infringe the copyright, trademark, privacy, publicity, or other personal or proprietary rights of any person or entity.

(d) The Submission must not contain or reference any names, products or services of any company or entity or any third party trademarks, logos, trade dress or promotion of any brand, product or service.

(e) Submissions that are pornographic, defamatory, libelous, or Submissions that otherwise contain inappropriate content or objectionable material may not be submitted and may be removed at any time at Producer's sole discretion.

(f) The Submission must not contain any personally identifiable information of any person other than you. Should you include personally identifiable information about yourself in your Submission, you acknowledge and agree that such information will be disclosed publicly and you are solely responsible for any consequences thereof.

(g) Producer reserves the right at its sole and unfettered discretion to disqualify any Submission that it believes violates or potentially violates any of the foregoing requirements or otherwise fails to comply with any provision of these Official Contest Rules. The decisions of Producer on this and all matters pertaining to the Contest shall be final and binding with no right of appeal. The top stories will be chosen by film industry judges, who will select the finalists to receive the "Overnight Red-Eye Flight". The winner will receive a round trip ticket to New York City for one night, including but not limited to: flight from a US airport of their choice to Los Angeles and from Los Angeles to New York City on the red-eye flight. This trip also includes hotel accommodation in New York City. In the event of a tie, there may be two finalists who will both receive the winning prize. All decisions are final and not subject to appeal. There is no monetary compensation for stories used for any of Overnight's advertisements and promotions.

## CONSENT AND RELEASE:

I understand that Fusion Film Group ("Producer") recently produced a motion picture entitled "Overnight" (the "Picture").
